About the QCTO

Established under the Skills Development Act, 1998 (Act No. 97 of 1998, as amended), the Quality Council for Trades and Occupations (QCTO) is the national governing body for the Occupational Qualifications Sub-Framework (OQSF). The QCTO plays a critical role in ensuring the quality and relevance of occupational qualifications, and in this way supports the development of a skilled and capable workforce to meet the evolving needs of the nation's economy.

The QCTO is managing a gradual shift from historically registered (legacy) qualifications, many of which date back to the 1990s, to modern occupational programmes that better meet current industry needs. As outlined in Government Gazette No. 50742, most older qualifications expired as of June 2023, with final enrolments and completions scheduled for 2027 and 2029, depending on the specific qualification. While the QCTO has granted limited extensions to ensure fairness and allow learners to complete their studies, the council remains committed to its strategic direction. The future of training in South Africa is occupational, and while no learner will be left behind, outdated qualifications must be phased out to make way for programmes that add real value.

The OQSF Explained

The Occupational Qualifications Sub-Framework (OQSF) is a component of the National Qualifications Framework (NQF). The OQSF focuses on occupational qualifications, skills development, and vocational training related to trades and occupations. It offers a comprehensive range of qualifications (Levels I–8) aligned with industry needs and career paths. Through partnerships with Sector Education and Training Authorities (SETAs), the QCTO ensures these qualifications reflect the latest industry demands.

The OQSF aims to facilitate the development and registration of quality-assured occupational qualifications, part-qualifications and skills programmes.

QCTO Qualification Types

Recognising the ever-changing job market, the QCTO offers various qualification types to cater to diverse learning needs. Our qualifications equip learners, professionals, workers, the unemployed, and those not in education, employment or training (NEET) with relevant and transferable skills. We offer the following qualification types:



Occupational Qualification: A qualification associated with a trade, occupation or profession resulting from workbased learning; such a qualification is registered on the NQF



Part Qualification: An assessed unit of learning with a defined outcome that is registered as part of a qualification on the NOF



Skills Programme: An occupationally based learning programme that when completed will constitute or contribute credit/s towards a qualification or part qualification registered on the NQF



Trade Qualification: An artisan certification for skilled trades

Who Can Be Accredited by the QCTO?

Any Skills Development Provider (SDP) that offers training under the OQSF must seek accreditation from the QCTO. The QCTO implements the accreditation process in partnership with its QPs, as outlined in signed service-level agreements. QPs include SETAs, the National Artisan Moderation Body (NAMB) and professional bodies.

The QCTO accredits SDPs for:

- Occupational qualifications
- Occupational part- qualifications
- Occupational skills programmes
- NATED 190/191 (N4-N6)







II Is There Funding to Study for QCTO Qualifications?

How Can I Verify if an SDP is Accredited with the QCTO?

Information on the accreditation status of SDPs is available on the QCTO website. It is important to note that the QCTO is not the only accreditation body. Other organisations, such as Umalusi, the Council on Higher Education (CHE), SETAs and professional bodies, also accredit educational programmes or qualifications. However, all qualifications (full and part, or pre-2009) should be registered on the NQF.

Where Can I Study QCTO Qualifications?

QCTO qualifications offer a wide range of learning opportunities through a network of accredited SDPs across South Africa. Here are some of the places you can find them:



Technical and Vocational Education and Training (TVET) Colleges: Public institutions offering career-focused programmes aligned with QCTO qualifications



Sector Education and Training Authorities (SETAs): Industry-specific organisations that may offer learnerships incorporating QCTO qualifications



Private Providers: Registered institutions delivering QCTO-accredited training programmes



Private Colleges: Institutions offering various learning pathways, including QCTO qualifications



Industry Training: Companies that may provide in-house training programmes aligned with QCTO qualifications
